The 2018 Colorado Springs Coin, Currency, and Collectibles Show will be held at the Colorado Springs Event Center, Hall A, 3960 Palmer Park Blvd., Colorado Springs, CO 80909.

Note: Bourse Floor will open prior to 2 PM if we are ready; security might not be on the floor yet

Security: There will be armed security on the Bourse Floor beginning at 1:30 PM on 20 June. Bourse Security will continue, uninterrupted, until 5:30 PM on 23 June.

The following is for your information and compliance. Acceptance of your application is not automatic and is subject to Bourse Chairman approval. Your signature on the Bourse Application indicates your agreement to abide by the following:

- 1) Payment: to reserve table(s) for the 2018 CSCCCS, this application needs to be completed, signed, and mailed with a down payment of at least \$100.00 (or full payment if possible). Make checks payable to: Kenneth L. Byrd and mail to: PO Box 62842, Colorado Springs, CO 80962. Final and complete payment (tables, cases, and lamps) must be paid prior to 1 March, 2018 to retain the same location (or move forward) from the previous year. If full payment is not received by 1 March, 2018, your table space may be re-rented and you may lose your position on the Bourse Floor and go to the back of the room.
- 2) Bourse Tables: are 8' x 30" with 8' x 30" backups (some backups (corners/endcaps) may be smaller)
- 3) Table Fees:

Regular 8' Table:	\$250.00 for the first table	\$225.00 for each additional table
Corner Tables:	2 x 8' and up to 1 x 8' backup	\$425.00
Inside Island End-Cap:	2 corners together (4 x 8' tables & up to 2 x 8' backups)	\$800.00

Note: dealers sharing need to pay \$25 for each additional table sign

- 4) Only registered dealers are allowed behind their tables. Badges are limited to two per application (additional badges cost \$5.00 each). No table may be sub-let without prior Bourse Chairman approval. Sub-letting is limited to one dealer per application (cannot sub-let at the show).
- 5) Early Bird badges are \$50.00 and are good for the entire show, except the first hour of dealer set-up on Wednesday.
- 6) Dealer and Early Bird badges must be prominently (must be easily visible) worn at all times.
- 7) Early cancellation notices will be subject to a \$50.00 cancellation fee and resale of the bourse space. Cancellation notices received after 1 April, 2018 will be subject to a charge of \$150.00 and resale of the bourse space. "No Show" will forfeit all payments.
- 8) There are a limited number of rental cases, lamps, and extension cords. Rental is strictly on a "first come" basis. Cases may be rented for \$20.00, lamps for \$10.00, and extension cords for \$5.00. If not indicated on the application (have to rent at the show) prices will be \$25.00, \$15.00, and \$7.00 respectively (if they are available).
- 9) Show helpers (from the local coin club/society) will be available for a nominal tip. The Show provides one dealer sign (additional signs cost \$25 each), table covers, electrical cords, and light bulbs (with lamp rentals).
- 10) Applicant releases Ken Byrd, the Colorado Springs Numismatic Society, the Colorado Springs Coin Club, and any officers thereof, from liability for any loss, theft, or damage sustained during the 2018 CSCCCS.
- 11) Dealers that do not have a Colorado Single Event License or Colorado Springs sales tax license may remit sales taxes to Ken Byrd. Coins and bullion are subject to a city tax of 3.12%, other items are subject to state, county and city tax of 8.25%. These rates are subject to change; the most current rate will be posted in your dealer package, handed out at dealer registration.
- 12) Any person found to have material which, in the Bourse Chairman's opinion, is counterfeit or otherwise unsuitable, will be asked to place the material in the custody of the Bourse Chairman until after the show. Any dealer refusing to abide by these regulations or who knowingly offers to sell, or sells, unsuitable material, will be asked to leave the show (without refund) immediately. This applies to floor trading as well.
- 14) Rules, regulations, and location of this coin show are subject to change.
- 15) For the 2018 CSCCCS we have procured a block of rooms at Hotel Elegante. Besides all of the other things happening in Colorado Springs the week of the show there will be a PGA Golf Tournament at the Broadmoor. This event will stress available hotels and increase room rates so book as early as possible. For Hotel Elegante, the room rate is \$119 per night (up to four people). With breakfast, rooms are \$129. The Elegante has an Airport Shuttle to and from the Colorado Springs Airport and if it is not taking customers to the airport, it will transport you to and from the show. To book your room call 1-800-981-4012 by Sunday, 20 May 2018. Identify yourself as a member of the Colorado Coin Show or reference the Group Reservation #: 1912275. All reservations must be guaranteed and accompanied by a first night deposit or guaranteed with a credit card.
