THE FOLLOWING CONSTITUTES TERMS AND AGREEMENT FOR BOURSE SPACE AT THE GREATER JACKSONVILLE COIN SHOWS, SPONSORED BY THE GREATER JACKSONVILLE COIN CLUB (GJCC):

1. Bourse tables are available to bona fide dealers and club members only, for the displaying, buying and selling primarily of numismatic related items. This is an invitational show and will be filled on a categorical basis. **Table spaces are considered reserved upon full payment, if you wish to keep the same location please pay early and in full.**
2. **PLEASE BE SURE TO ORDER TABLE SPACE BASED ON YOUR NEEDS, ADDITIONAL 6' BONUS TABLES ARE ISSUED WHEN SPACE PERMITS at \$25, ONLY ONE PER BOOTH AND ARE NOT GUARANTEED, bonus tables DO NOT include additional backup tables.**
3. This agreement may be canceled up to 45 days prior to the show & the bourse donation will be refunded.
4. GJCC Dealer badges must be worn at all times while on the floor. A maximum of two badges are provided per table, there is a charge for extra working personnel and badges, The bourse room is non-smoking.
5. Dealers must secure their own insurance. Insurance is not provided by the GJCC or facility against casualty, fire, or any loss of property or any injury to dealer, agent or employee.
6. The dealer understands and agrees by signing below that GJCC is not an insurer nor does GJCC intend in any way to provide insurance at any time incident to the show. Further the dealer releases and forever discharges GJCC, it's officers, directors or members of any actions, causes of actions, suits, proceedings, debts due contracts, judgments, damages, claims or any demands whatsoever in law or equity which may arise from any loss whatsoever including loss, damage, physical injury, however sustained, directly or indirectly in connection with the show.
7. The sale of altered or counterfeit materials is strictly forbidden by Federal Law and forbidden by GJCC, and the GJCC reserves the right to prohibit the display or sale of any item not conforming to accepted standards of numismatic property. Items of questionable numismatic authenticity must be removed upon request.
8. Bourse space may only be sublet with the prior permission of the bourse chair.
9. Bourse Chair can place a Dealer at the Chair's own discretion and has the right to refuse or to eject any party is at the sole discretion of the Bourse Chair.
10. **Bourse space must be vacated Sunday June 4th by 5:30 pm.**
11. If security is needed beyond show closing, contact security upon entering the show (any extra time is at Dealer expense).
12. All dealers will be responsible for all sales tax in accordance with Florida State Law.
13. Dealers without tables are invited at Dealer Setup times at \$25 per person, payable at the door.
14. The undersigned states and agrees that he/she is an authorized agent for the company and agrees to full compliance with the above articles. **SIGNED APPLICATION AND PAYMENT MUST BE ON FILE BEFORE ACCESS TO TABLES.**
