Applicant agrees to provide all licenses and permits and to obey all applicable statutes and ordinances.

**ATTENTION DEALERS**

Make sure you have provided printed legible badge names on the lines provided above. If the names are not listed by November 15, 2018, you will be charged an additional \$15.00 per badge at the time of registration. Bourse application cannot be accepted unless properly signed on the reverse side.

## CONDITIONS

1. Only individuals listed on the bourse application or otherwise officially accredited to booth holder ID Badges shall be permitted behind bourse tables booth. All Dealers must be ISNA members.
2. Booth holder badges are not transferable and shall not be loaned or given to others. Violators of this provision may result in suspension of bourse privileges.
3. at least 80 percent of material on display must be numismatic in nature and may include: US, Confederate, Ancients, Foreign, Coins & Currency, Stamps, Tokens, Medals, Bonds, Coin related jewelry only and exonomia related material. No modern goods or collectibles are allowed (e.g.: porcelain, china, rocks, arrowheads, mardigras items, Indy 500 items, modern jewelry, dolls, beanie babies, NASCAR item, basketball cards, football cards, baseball cards or any other collectible items not related to numismatics,) and may be removed by the bourse chairperson and/or the ISNA President.
4. It is understood and agreed that no refunds of bourse fees will be made after November 1, 2018. Any request for refund must be presented in writing to the Bourse Chairman prior to November 1, 2018. You may also apply your bourse fee to the 2019 show in the event of a cancellation prior to November 1, 2018.
5. NO COINS DISPLAYS, BOOKS OR SIGNS OF ANY NATURE CAN BE PLACED ANY HIGHER THAN FOUR (4) FEET FROM THE FLOOR. SECURITY MUST HAVE A CLEAR VIEW ACROSS THE ENTIRE BOURSE AREA TO ENSURE SECURITY FOR THE ENTIRE AREA. SIGNS OR BANNERS NOT PROVIDED BY ISNA ARE PROHIBITED. NO SIGNS OR ADVERTISING MATERIAL OF ANY KIND MAY BE AFFIXED TO ANY WALL. A MARRIOTT REQUIREMENT!
6. Booth holder agrees to maintain the booth in the arranged configuration as supplied by ISNA. Booth holder agrees not to use supplementary tables not supplied by ISNA as part of the standard booth configuration.
7. Booth chairperson may reassign tables not claimed by the deadline date of the bourse fees of November 1, 2018. Contracts state all bourse fees and balances must be paid by November 1, 2018, and any booths not claimed by 10 AM on Friday, December 14, 2018, may be reassigned with no refund to the booth holder.
8. No alcoholic beverages of any kind are allowed on the bourse floor at any given time.
9. No subletting of bourse tables!
10. All dealers are required to have on hand their state registered retail merchants certificate or a copy of the same.

**ALL DEALERS THAT HAVE PAID FOR A BOURSE TABLE AT ANY ISNA SHOW MUST FILL OUT AND SIGN THE ISNA BOURSE CONTRACT FOR THAT SHOW. FULL PAYMENT OF ALL BOURSE FEES IS DUE ON OR BEFORE NOVEMBER 1, 2018. NO REFUNDS WILL BE MADE AFTER NOVEMBER 1, 2018.
