## **BOURSE APPLICATION AND CONTRACT**

## THE FOLLOWING CONSTITUTES THE TERMS OF AGREEMENT FOR BOURSE SPACE AT THE TAMPA BAY COIN CLUB (TBCC) NUMISMATIC SHOW:

- Bourse tables are available to licensed dealers and collectors (referred in the contract as "Vendors") for the displaying, buying and selling numismatic related and other approved items. This is an invitational show. Tables will be reserved with payment in **FULL** by Nov.1st, 2018. After the 1st, tables on first come, first serve basis.
- This agreement may have canceled before Nov.1<sub>st</sub>, 2018 and 75% of the bourse donation will be refunded. I.D. badges must be worn always in the bourse area. Bourse area is a **NON-SMOKING** area.
- Vendors must secure their own insurance. Insurance is not provided by the Tampa Bay Coin Club, the security firm hired by same, or the Big Top against casualty, fire, or any loss of property, injury or otherwise to any vendor, agent or employee.
- The sale of altered or counterfeit materials is strictly forbidden by Federal Law and forbidden by the Tampa Bay Coin Club. TBCC reserves the right to prohibit the display or sale of any item not conforming to accepted standards of numismatic property. Items of questionable numismatic authenticity must be removed if requested. No numismatic items will be allowed on a case by case basis.
- Bourse space may be sublet only with the permission of the Chairman of the Bourse.
- The vendor understands and agrees that Tampa Bay Coin Club is not an insurer nor intends in any way to provide insurance at any time incident to the show. Further, the vendor releases and forever discharges Tampa Bay Coin Club, including all officers and members of any and all manner of actions, causes of actions, suits, proceedings, debts due to contracts, judgments, damages, claims or demands whatsoever in law or equity which may arise from any loss whatsoever including loss, damage, physical injury, however sustained, directly or indirectly in connection with the show. The Tampa Bay Coin Club may plead this release and bar claim, demand, or course of action instituted.
- Bourse Chairman can place a vendor at his own discretion. Interference by any vendor with the activities of another registered vendor will not be tolerated. Any such occurrence should be reported immediately to the Bourse Chairman. The vendor found to have committed the offense may be asked to leave the show and may also be prohibited from participation in any future Tampa Bay Coin Club events.
- Bourse space must be vacated Saturday, December 8, 2018 by 4 PM.

TABLE COST WITH BACKUP - 8' - \$65.00 (Cost valid until Nov.1st, 2018)

- Upon registering for the show, if cases or lights are needed, they may be reserved & rented on a first come, first served basis for a fee of \$10.00 per showcase and \$5.00 per clamp table light.
- All vendors will be responsible for all sales tax in accordance with Florida State law.
- The undersigned states and agrees that he/she is an authorized agent for the vendor listed below and agrees to full compliance with the above articles.
- No signage over 18" high unless approved by the Bourse Chairman. **NOTHING** attached to walls.
- Vendors vacating their spaces prior to 2:30 PM will risk loss of table and/or preferred location at future shows. 15-Upon request, vendor with physical limitations will be provided help to bring their show material in & out of the hall.
