The BIG ISLAND COIN CLUB presents its Eleventh "Collectibles, Antique and Coin Show" on Sunday, May 7, 2017, from 9:00 a.m. to 3:00 p.m. at Aunt Sally Kaleohano's Luau Hale (formerly referred to as Seven Seas) at 799 Pi'ilani Street Hilo, Hawai'i.

This location is in the heart of Hilo with plenty of parking, easy access and a trusted, air conditioned location. Admission is free for members of the public. The show will again retain the presence of a fully authorized Hawaii Police Department Officer in full uniform for the show's setup, the duration of the show, take down and departure.

The Dealer Table Fee is \$45.00 and entitles the registered user to the use of one 8 ft. table and two chairs. Flat, tabletop display cases are available for \$10.00 per case. Additional tables are available at a cost of \$35.00 each. The Dealer Table Fee must be paid in advance to reserve a table. There are a limited number of tables that fit in this room comfortably. It is anticipated all returning participants will be able to reserve the same number of tables they reserved for the Spring 2016 show, but this is not guaranteed.

RETURN YOUR DEALER RESERVATION FORM AND FEE BY APRIL 15, 2017.

The show's co-chairs will assign the locations based on experience and input from previous, participating dealers. The aisles will be flow-through, with enough room in the aisles to allow customers a non-hurried show experience. Successful dealers know the balance between inviting the public to view wares without putting undue pressure. The Aloha Spirit is our guiding light.

Set-up begins at 8 a.m. ONLY SHOW PERSONNEL, DEALERS, AND THEIR REGISTERED WORKERS MAY ENTER BEFORE 9:00 A.M.

We are asking for THREE items from each dealer for our Door Prizes. Please give them to our Club Member at our table by the entrance.

RULES AND GUIDELINES

1) The basic table categories are:

A) Flats, coins, tokens, numismatic items, currencies, medals, jewelry, maps, comics, postcards, historic documents, netsuke, watches and small items.

B) Stand-ups; bottles, jars, vases, artwork, statuary, masks, vintage toys, vintage clothing and other three-dimensional items larger than a demitasse cup.

2) The price of table rental has been determined and is attached. Flat dealers can expect to present two to three flat cases per table. Stand-ups dealers can be expected to have one to three tables with or without cases. Dealers are asked to dress their tables with tablecloths. Bring your own front table cover if you desire. Dealers may not bring their own tables and chairs. Items may only be hung from the walls of the complex in specifically designated areas, please contact show chairs in advance if you have hanging items.

3) The professional coin dealers showing mainly flats will be placed nearest the entrance (in a sequence that rotates from year to year).

4) Dealers with stand-ups may use one table only or two tables in an L-shaped configuration or three tables in a U-shaped configuration. Table-top shelving brought by dealers must be placed against the wall or on the floor out of the aisle. Keep your area safe for all.

5) No interception permitted. Members of the public seeking to sell will only be directed to the proper show section by Show Staff at the Show Entrance. Only the Table Dealers may refer the selling or engage the buying public to other specific dealers on the bourse floor.

6) Dealers are asked to please set up with diverse and interesting merchandise to engage the buying public's range of interest and thus create a favorable overall impression. Remember, the public is being educated by the many shows on TV about the value of all types of collectables. Let's show them what you have. We will also have numismatic educational tables.

7) BREAKDOWN OF YOUR AREA BEFORE 3:00 PM WILL NOT BE ALLOWED.

8) All vendors and dealers are required to be in possession of a valid General Excise tax license and record all transactions in accordance with State and County laws.

9) Loud, disruptive or behavior not consistent with the "Aloha Spirit" is not permitted. Negotiating prices and values will be conducted in straightforward, but respectful manner. Violators may be asked to leave; violators will not be asked to return for future shows. NO DEALERS WILL BE PERMITTED TO DENIGRATE ANOTHER DEALER'S WARES OR ACTIVITIES.

Dealers conducting themselves in any manner considered by show organizers, or violating the basic rules and terms of the property, or in a manner considered to be offensive or not in the Aloha Spirit will not be permitted to return in future shows at the very least and may be required to leave the premises immediately and without undue or noisome protest. Please remember cases of extreme action will only be undertaken to preserve the trade nature of the show and the Aloha Spirit we all aspire to protect. This is simply good business sense and conduct.

10) Guest workers are prohibited. Only authorized workers, named in the original Dealer Reservation Form, will be permitted to work. Friends of dealers will not be permitted to enter the bourse early during or during set-up; this could affect everyone's need to setup in a timely fashion. THERE WILL BE ABSOLUTELY NO LOITERING DURING SET-UP AND TAKE DOWN. THIS IS FOR SECURITY REASONS AND OUR AUTHORIZED HAWAII COUNTY POLICE OFFICER WILL ENFORCE THIS REQUIREMENT. Please kokua!

11) The public must vacate the premises in a timely manner at the close of the show. Again, this is for security reasons. Your kokua is greatly appreciated!

Let's all work together to make the Spring 2017 Collectibles, Antique and Coin Show another great success!
