AGREEMENT: The applicant hereby agrees to defend, indemnify, and hold harmless the Danbury Coin Club (DCC), its members, the show venue, and any sponsors from any liability or responsibility for any loss, damage or injury that may occur to the applicant, the applicant's associates or employees, or any of their property, before, during, or after the contracted show. It is the responsibility of Dealer to maintain proper insurance for property and liability and their own security if they deem necessary. Dealers are expected to be at the show with inventory out for sale until at least 3:30pm. The Dealer agrees that in the event the dealer fails to install his or her products in his assigned space prior to the start of the show, The Danbury Coin Club shall have the right to take possession of said space and lease all, or any part thereof to another party.

Dealers are expected to bring their own lamps, bulbs, extension cords, and showcases. Tables are awarded on a show-to-show basis, we reserve the right to put a Dealer in any bourse position. Dealers may not use their back up tables to add selling space. Dealer shall not assign a third party its right to the exhibit space or any portion thereof without written permission from the show chair. Dealers passing bad checks to the club, or other Dealers will not be offered a table at any future shows. Cancellation of any portion of this contract by the Dealer will be accepted only if it is at least 14 days prior to the show date. In the event of cancellation, DCC will not offer Dealer a refund, but instead will provide the Dealer with the opportunity to enter into a contract for a future show date, utilizing the bourse fee paid with this contract.

Dealers are responsible for all state, federal and local laws regarding retail sales and Dealer must collect his own sales tax if applicable. Dealer agrees to abide by all show rules provided either verbally or in writing. Dealers in breach of contract may be declined a table at following shows, per show chair decision. Signing below or Payment or Partial payment, indicates that you have fully read and fully understand and accept these terms and conditions contained herein.
