Application is hereby made for a bourse table for the period of the above show and convention. It is understood that the fee will include the use of table space with limited or no backup. **Table Fees: 6ft. wall w/backup = \$175. 6ft. center isle w/limited backup = \$150. A select number of 3ft. tables may be available = \$90.** Saturday only tables are sometimes available and are wait- listed with an 8am entry = \$100 each. Rental Cases are \$15 each, lights are \$10 each. No more than two approved LED lights are allowed per table. Please no exceptions. Tables may not be transferred, resold, loaned, leased, shared or sublet, in whole or in part, without written consent of the Bourse Czar. Tables not occupied by 9 am Friday, or have been vacated, resort back to the Bourse Czar for resale for wait listed dealers. Nothing is to be bought or sold that is prohibited in the area of the show. Smoking and alcohol is not permitted on the bourse floor. After setup, only the front entrance may be used. Dealers and assistants must wear the official dealer badge. No more than one dealer and one assistant are allowed per table. **All dealers must be members of the ANA and BFC&CC.** Applications for both organizations are available; ANA membership is \$46 yearly and Brentwood-Franklin Coin Club is \$10. It is not necessary for Assistants to be members of either organization. Only dealers and working assistants are admitted to the Bourse prior to the public and are allowed behind tables. Early Bird entry passes are sold for dealers without tables for \$50 who must also be members of ANA. *Please do not add other dealers to you contract as we need more advertising the money!* There is a 100% refund 30 days prior to the show. We currently have a waiting list. **If a dealer has any complications or emergencies that prevent attendance, fees may be rolled-over to the next year with bourse czar approval. We only ask you notify us as soon as possible.**

Dealer Setup: Thursday, Noon - 6pm; Friday and Saturday at 8am (Please do not ask to be admitted earlier!)

Public Hours: Friday 9am-6pm; Saturday 9am-4pm

This is primarily a dealer run show, run by dealers. Table location assignments are not guaranteed for anyone. They are assigned by the Bourse Czar for all dealers whose full bourse fees have been paid and are also based on their assistance in helping conduct and promote our show prior, during and any assistance to ICTA for TN. No Bozos or freeloaders. Security precautions are being taken to provide us protection and be continuous on the premises from Thursday noon to 6pm Saturday. However, there is no insurance carried by the Coin Show, COL Steven Ellsworth, ret., Butternut, its committee or any sponsoring club. None of these mentioned parties will be held responsible for any loss, damage, or injury that might be sustained by those assigned space in the bourse, to their employees, or property, from any cause whatsoever, prior to, during, or subsequent to the period covered by this contract. The signature for the applicant and its acceptance by the Bourse Czar constitute a contract in accordance with the terms hereof.
