It is understood and agreed that a fee of \$80 per 8 ft. table will be due and payable by February 15, 2018 for \_\_\_\_ tables. We will not supply any tables for your personal needs along the wall. If you bring in a folding table for your personal use it may not be used for the selling of any merchandise at the show. No other tables will be permitted.

Those anticipating in the bourse will furnish their own lights, cases, and carts.

It is further understood and agreed that this contract is non-negotiable and the signer of the same must occupy the space contracted for and cannot transfer it to another person or persons. Tables cannot be shared with anyone without permission of the Bourse Chairperson.

There will be no insurance coverage carried by the show committee, Interstate Coin Club or the Grand Venice Baymont Inn. The above mentioned shall not be responsible for loss, theft or damage or any type of injury that may occur to the assigned bourse space, employees, dealers or property under this contract before, during or after the show.

The undersigned applicant releases the above mentioned parties from all claims from loss, theft, damage or any type of injury that may occur. The applicant also agrees to abide by the rules set by the SHOW COMMITTEE.

AS MARYLAND STATE TAX MUST BE COLLECTED AT THE RATE OF 6% ON EACH DOLLAR, YOU ARE REQUESTED TO COLLECT AND REMIT THE TAX DIRECTLY TO THE STATE OF MARYLAND.

It is also required in the State of Maryland to have a valid Maryland Traders License. If doing less than 3 shows a year in Maryland an affidavit is needed in lieu of the Traders License.

No Alcoholic beverages will be allowed in the ballroom at any time.

The signature of the applicant and its acceptance by the Bourse Chairman or committee constitutes a contract in accordance with the terms therein.
