## Conditions of the 2020 Bourse Contract

In order to secure a dealer table, a \$100 deposit must be submitted with the dealer contract. The remainder of the balance due must be paid by August 1, 2020. Applications with balances not paid in full by August 1, 2020 may be cancelled and the deposit returned minus \$25 in processing and costs associated.

Contracts can be cancelled without penalty up to 45 days prior to the event in writing by the contract holder. After 45 days prior to the event, the contract is binding, and no refund of any fees will be returned. Reasons such as medical, hospitalization, family emergencies and or a family death will be decided on a case by case manner and decided by the show board of Directors.

It is agreed that this contract is not negotiable and the signer of same must occupy the space contracted for and cannot transfer or subcontract it to another person or persons.

The Bourse Chair reserves the right to assign and/or reassign bourse space at his/her discretion.

No pieces of equipment are to be behind tables that will obstruct other dealers from using the area as a walkway. **No backup table will be permitted to be used as a bourse table.**

The sale of counterfeit coins, bullion, currency, stamps, or historical artifacts without the words "counterfeit" or "copy" is strictly forbidden. Any dealer doing so will be immediately asked to leave and barred from submitting future contracts to the Harrisburg Coin Club.

You must have this contract in your possession when on the Bourse floor. Only those persons listed on the Dealer's Bourse Application and wearing an official convention identification badge shall be permitted behind booth tables. ID Badges must be worn at all times when on the bourse floor.

Our Show Committee will furnish armed security protection for the Bourse and exhibits during the period of the show. The Show Committee members, the Harrisburg Coin Club, Inc., and the Scottish Rite Masonic Cathedral will not be responsible for any loss, theft, damage or any type of injury that may occur to those individuals assigned Bourse space under this contract, to their employees or property from any cause prior to, during, or after the show. The undersigned applicant releases the above-mentioned parties from all claims arising from loss, theft, damage, or any type of injury.

The applicant also agrees to abide by the rules set forth by the Show Committee. The signature of the applicant and its acceptance by the Show Committee Bourse Chairman constitutes a contract in accordance with the terms specified herein.
