**CONTRACT STIPULATIONS and CODE OF CONDUCT**

1. Displays cannot interfere with an adjacent dealer's space or block sight line.
2. Ad copy created referencing the *PAN Show* must have show committee approval.
3. Firearms must not be openly displayed.
4. No pets, music, or unprofessional conduct will be tolerated.
5. Tables cannot be sold, transferred, or shared without the approval of the show chairman.
6. All dealers and staff must abide by all federal, state, and, local rules and regulations.
7. All assistants or relatives must be PAN members and listed on the contract.
8. Dealers sharing a table must be dealers with full address listed on the application.
9. Individuals purchasing **EARLY BIRD BADGES \$50.00** must be PAN members and are not permitted behind dealer tables.
10. Only two wheeled carts are permitted on the floor during show hours.
11. The liability of PAN is limited to the refund of the bourse fee in the event of show cancellation.
12. Dealer cancellation allowed 30 days before show start date and a \$50.00 cancellation fee assessed to all refunds.
13. Discounts apply only to payment in full made by stated date on front side of the contract.
14. Any over payments will be considered a donation to the PANKidZone.
15. Cut off date to be included in the program booklet is 10 days prior to the first day of the show.
16. All bourse fees, PAN dues, associate dues must be paid in full before permission to set up is granted.
17. All buying and selling is to be done on the bourse floor and during show hours.
18. Material for sale must be at least 75% coins, paper money, tokens, bullion, numismatic items or Show Chair's discretion.
19. Supplies may only be sold by the PAN sanctioned Supply Dealer.
20. Dealer agrees to all photography and/or video done by PAN or any agent there of.

**DEALERS OFFERING ALTERED, COUNTERFEIT, OR SPURIOUS MATERIAL OR ENGAGING IN OR CONDUCTING BUSINESS IN AN UNETHICAL MANNER WILL BE SUBJECT TO EXPULSION FROM THE SHOW WITHOUT RECOURSE.**

**PAN WILL PROVIDE PROFESSIONAL ARMED SECURITY ON THE BOURSE FLOOR FROM THE STATED BEGINNING TIME UNTIL THE STATED ENDING TIME.**

**NO INSURANCE WILL BE CARRIED BY PAN OR THE MONROEVILLE CONVENTION CENTER TO COVER ANY LOSS, DAMAGE OR INJURY TO THOSE ASSIGNED SPACE ON THE BOURSE AREA INCLUDING THEIR EMPLOYEES OR PROPERTY FROM ANY CAUSE WHATSOEVER, PRIOR TO, DURING OR SUBSEQUENT TO THE PERIOD COVERED TO BY THIS CONTRACT. THE UNDERSIGNED EXPRESSLY RELEASES PAN, THE SHOW COMMITTEE, THE MONROEVILLE CONVENTION CENTER FROM AND AGREES TO IDEMNIFY SAME AGAINST ANY AND ALL SUCH LOSS, DAMAGE, OR INJURY.**

Applicants assume full responsibility for themselves, relatives, assistants, and sharing dealers.  
Signature of applicant and acceptance of the show committee, with the right to reject for any reason without explanation or recourse, constitutes a contract in accordance with the above stated terms.
