3. Cancellation Policy
 - 0 to 40 days before Expo opening \$50.00 per table.
 - 41 to 90 days before Expo opening; total fees will be used for the next Expo.
 - 91 to 120 days full refund.
4. Dealer badges must be prominently (must be easily visible) displayed and worn at all time on the Expo floor.
5. No counterfeit or otherwise unsuitable material allowed on the Expo floor.
6. NMCSC - Expo agent(s), owner(s) or officer(s) have the right to close, without liability of any kind, the space of any exhibitors who refuses to conform to the rules and condition of the NMCSC - Expo.
7. No video or photography on the NMCSC - Expo floor without prior permission of the NMCSC - Expo.
8. Numismatic exhibitors are asked to follow the ANA Dealer Code of Ethics. All exhibitors are asked to deal in a fair and honest way with the general public and other exhibitors.
