I hereby apply for _____ bourse table/s for the time period specified for the 80th Coin Show of the Lebanon Valley Coin Club, Inc. The dealer rental fee of ***\$90.00 per table**, 8 ½ feet by 2 ½ feet, shall accompany this application/contract. **Participants in the bourse will furnish table covers, cases, lamps-only two lamps per table with 60 watt bulbs maximum, and extension cords.**

Security services will be provided from 7:00 AM until 3:30 PM. The Lebanon Valley Coin Club, Inc. and Days Inn will not be responsible for bourse members' loss of or damage to personal property; for personal injury to bourse dealers, their family members, or employees of bourse members assigned space at the 79th Coin Show of the Lebanon Valley Coin Club, Inc. **Please handle all fire arms responsibly.**

The undersigned bourse applicant releases the Lebanon Valley Coin Club, Inc. and Clarion & Roadway Inn of all claims arising from bourse dealers: loss of personal property; damage to personal property; personal injury to self, family members, or employees of bourse dealers assigned table space. The bourse applicant, family members, and their employees agree to abide by the bourse guidelines set forth by the Coin Show Chairperson David Greely.

A bourse dealer shall not: engage in any table encroachment, set up any type of table extensions beyond the assigned 8 ½ feet by 2 ½ feet table, share a table with or transfer a table to another dealer without the approval of the Show Chairperson. Back up tables are permitted behind an assigned space. Dealers are expected to observe firearm safety. Cancellation refunds - seven days or more notice.

The Show Chairperson reserves the right to deny bourse space to a coin/currency dealer or an employee of a dealer who did not abide by bourse guidelines or who did not conduct themselves in a professional manner at a previous coin show sponsored by the Lebanon Valley Coin Club, Inc.

The signed applications/contracts once accepted by the Coin Show Chairman constitute a contract in accordance with the terms written herein. Confirmation of a bourse reservation will be indicated by the returned application/contract signed by a Show Chairperson. Bourse space will be assigned according to previous attendance at a Lebanon Valley Coin Club, Inc. show and/or the date of receipt of the applications/contracts accompanied with the table reservation fee.
