BOURSE APPLICATION AND CONTRACT

Show Hours: November 20th & 21st, 2021 – 9 AM to 3 PM / Set-up: 7 AM to 9 AM

THE FOLLOWING CONSTITUTES THE TERMS OF AGREEMENT FOR BOURSE SPACE AT THE HOLIDAY NUMISMATIC SHOW:

- Bourse tables are available to licensed dealers and collectors (referred in the contract as "Vendors") for the displaying, buying and selling numismatic related and other approved items. This is an invitational show. Tables will be reserved with payment in **FULL** on a first come, first serve basis.
- I.D. badges must be worn always in the bourse area. Bourse area is **NON SMOKING**
- TAMPA BAY COIN CLUB (TBCC) & CLEARWATER COIN CLUB (CCC) reserves the right to prohibit the display or sale of any item not conforming to TBCC & CCC standards. Sale of non-genuine numismatic material is strictly prohibited.
- Bourse space may be sublet only with the permission of the Chairman of the Bourse.
- Bourse Chairman can place a vendor at his own discretion. Interference by any vendor with the activities of another registered vendor will not be tolerated. The vendor may be asked to leave the show and may also be prohibited from participation in any future TBCC & CCC events. At the discretion of TBCC & CCC agents.
- Upon registering for the show, if cases or lights are needed, they may be reserved & rented on a first come, first served basis for a fee of \$10.00 per showcase.
- All vendors will be responsible for all sales tax in accordance with Florida State law.
- Vendors must secure their own insurance. Insurance is not provided by the TBCC & CCC, the security firm hired by same, or the Oldsmar Flea Market owners or agents, against casualty, fire, or any loss of property, injury, loss or otherwise to any vendor, agent or employee.
- The vendor understands and agrees that TBCC & CCC is not an insurer nor intends in any way to provide insurance at any time incident to the show. Further, the vendor releases and forever discharges TBCC & CCC, including all officers and members of any and all manner of actions, causes of actions, suits, proceedings, debts due to contracts, judgments, damages, claims or demands whatsoever in law or equity which may arise from any loss whatsoever including loss, damage, physical injury, however sustained, directly or indirectly in connection with the show. The TBCC & CCC may plead this release and bar claim, demand, or course of action instituted.
- Bourse space must be vacated by Sunday November 21st, 2021
- No signage over 18" high unless approved by the bourse chairman. **NOTHING** can be attached to the walls.
- Vendors vacating their space prior to 2:30pm on Sunday November 21st, 2021 will risk loss of table and/or preferred location at future shows.
- The undersigned states and agrees that he/she is an authorized agent for the vendor listed below and agrees to full compliance with the above articles.
