The show will be held on Jan _____ 2020 in the Foley Civic Center (one mile east on Highway 98 off of Gulf Shores Parkway in downtown Foley). The table fee entitles the dealer to access to electrical outlets. Lamps, extension cords, table covers, and show cases will not be provided. Security will be provided by armed off duty police from Friday 5pm to Sat 8am and Sat 5pm to sun 8am through to the close of the show Sunday. We do not provide liability coverage and you will be responsible for insurance against loss. There will be no smoking on the bourse floor and The Civic Center per City of Foley Regulations this include vapor and electronic devices.

In addition to local publicity, show notices will appear in Coin World, FUN Topics, and other Numismatist publications of our selection. We will also be distributing circulars at other regional shows.

Dealers may elect to set up Friday evening from 3:00 PM till 6:00PM or Saturday Morning from 7:30 AM till 8:30 AM. The bourse is open to the public from 9:00 AM till 5:00 PM on Saturday and 9:00 AM till 3:00 PM on Sunday. There is NO SMOKING in the Foley Civic Center Building per Local Regulations. The Club Does not furnish Meals at Lunch. Breakfast pastries and coffee will be provided.

Assigned table(s) cannot be rented, sold, loaned or leased by any individual other than the applicant. Any dealer who vacate their rented table(s) prior to the publicized end of the show SBNA have the right to rent or lease that same table without recourse. Dealers are required to vacate the bourse area within 1 hours after the show at 3pm on Sunday.
