Security: There will be armed security on the Bourse Floor beginning at Noon on Wednesday June 22nd, 2022 and will continue until the close of the show.

PLEASE NOTE: Hall B (Nextdoor to Hall A) will only be available for MOVE-IN on Wednesday June 22nd, 2022 from 11am until 6pm. Dealers will NOT have access to Hall B for MOVE-OUT.

The following is for your information and compliance. Acceptance of your application is not automatic and is subject to Bourse Chairman approval. Your signature on the Bourse Application indicates your agreement to abide by the following :

- 1) Payment: to reserve table(s) for the 2022 Coin X West- Powered by Roundtable Trading, this application must be completed, signed, and mailed with a deposit of at least \$100.00 (or full payment if possible). Make checks payable to: Coin X and mail to 11005 Olive Blvd. St. Louis, MO 63141, Attention Mary Woodside. Final and complete payment (tables, cases, and lamps) must be paid prior to May 1st, 2022 to guarantee your table space.
- 2) Bourse Table Options:
 - Premium* Corner Booth** (Two 8ft tables, 4 chairs, 3 lights, 3 showcases, trash receptacle, backup table, electrical outlet and 4 dealer badges)
 - Premium* 8ft Table** (One 8ft table, 3 chairs, 2 lights, 2 showcases, trash receptacle, backup table, electrical outlet and 2 dealer badges)
 - Regular Corner Booth** (Two 8ft tables, 4 chairs, 3 lights, 3 showcases, trash receptacle, backup table, electrical outlet and 4 dealer badges)
 - Regular 8ft Table** (One 8ft table, 3 chairs, 2 lights, 2 showcases, trash receptacle, backup table, electrical outlet and 2 dealer badges)

Premium Tables/Premium Corner Tables will be closest to the front entrance and in the main aisles and will be assigned in the order the application was received.
- 3) Only registered dealers are allowed behind their tables. No tables may be sublet without prior Bourse Chairman approval. Sub-letting is limited to one dealer per application (cannot sublet at the show).
- 4) Early Bird badges are \$50.00 and are good for the entire show.
- 5) Dealer and Early Bird badges must be prominently (must be easily visible) displayed/worn at all times.
- 6) Early cancellation notices will be subject to a \$50.00 cancellation fee and resale of the bourse space. Cancellation notices received after April 1, 2022 will be subject to a charge of \$150.00 and resale of the bourse space. "No Show" will forfeit all payments.
- 7) The show provides one dealer sign (additional signs are \$50 each), table covers, and light bulbs (with lamp rental).
- 8) Show helpers (from the local coin club/society) will be available for a nominal tip.
- 9) Applicant releases the Colorado Springs Event Center, Mary Woodside, Roundtable Trading and any officers thereof, from liability for any loss, theft, or damage sustained during the 2022 CSCCCS.
- 10) Dealers that do not have a Colorado Single Event License or Colorado Springs sales tax license may remit sales tax to the City of Colorado Springs. Coins and bullion are subject to a city tax of 3.12%, other items are subject to state, county and city tax of 8.25%. These rates are subject to change; the most current rate will be posted in your dealer package distributed at dealer registration.
- 11) Any person found to have material which, in the Bourse Chairman's opinion, is counterfeit or otherwise unsuitable, will be asked to place the material in the custody of the Bourse Chairman until after the show. Any dealer refusing to abide by these regulations or who knowingly offers to sell, or sells, unsuitable material, will be asked to leave the show (without refund) immediately. This applies to floor trading as well.
- 12) Rules, regulations, and location of this coin show are subject to change.
