Those requesting a refund will forfeit table location. Any table not occupied by noon on Friday **may be** resold unless Bourse Chairman is notified of a later arrival.
- Cancellations within 30 days of the show may forfeit the Bourse Fee except for medical reasons or family deaths. Cancellation within 7 days of the show, contact the bourse chairperson at: 321-427-6474.
