The 2023 show will be held at **St. Joseph of Cupertino Church, Parish Hall** in Cupertino. We are targeting 35-40 dealers for this show.

The **Parish Hall** is an excellent facility with a large, mostly rectangular room, and plenty of free parking. It is located about a mile west of I-280 near the south east corner of De Anza Blvd. and Stevens Creek Blvd. This location is easily accessible to all Northern California residents.

We will continue our policy of heavy advertising, including both national and local media, as well as online advertising and social media. We expect a very good turnout as this show is well-established and the public has responded by turning out in force. Security will be provided from set-up to closing.

New this year, we are offering hotel discounts for those wishing to arrive Saturday or even Friday. Four-star hotel Juniper Hotel is conveniently located at 10050 DeAnza Blvd in Cupertino. Reservations must be made at least 30 days in advance to take advantage of their discounted rates.

Also new this year, is our two sets of pricing. Early Bird prices are effective through February 15, 2023. After that date, regular pricing goes into effect. There will be no additional discounting offered. To secure the best locations on the bourse floor, reserve your table(s) early. A new option this year is the Premium Corner which includes two corner tables plus a third table. Get a prime location near the entrance with a Premium Corner.

2. The bourse fee for the show is:

16' corner group (2 tables)	\$324*
Premium corner (3 tables)	\$499*

\*After 2/15/2023, straights are \$179/\$349, corner group \$349, & Premium corner \$539

Each table or group includes front table(s), one backup table, table covers and electrical connections.

4. The full fee must accompany the Bourse Application to reserve your space. Cupertino Coin Club reserves the right to refuse any application. Applications will be processed in the order they are received. Tables are confirmed on a first-come, first-served basis with final table assignment based on your number of years of attendance at the show. Refunds will be made if the Bourse Chairman or Show Chairman is notified at least 10 days prior to the show date.

5. Bourse tables are to be occupied by the dealer and/or his/her assistant(s) as listed on the Bourse Application. No space may be sublet without the prior permission of the Bourse Chairman. Bourse badges are limited to two (2) per 8' table and three (3) per corner group, exclusive of spouses/children. **Please only list dealers who will be actively working behind your table.**

6. Cupertino Coin Club reserves the right to refund bourse fees, or part thereof, and expel from the show any dealer who misrepresents his/her merchandise by counterfeits, whizzed, reprocessed or other means or who does not abide by the above rules.
