Dear Coin Dealer

You are cordially invited to join with the FIRESTONE COIN CLUB in a one day coin show to commemorate its 63rd Anniversary at the **St. Matthew School Gymnasium, 2580 Berne Street, Akron, Ohio** on Saturday April 6, 2024. St. Matthew School is located in the Ellet section of Akron one block east of Canton Road (Route 91). This is the same locations as in previous years.

The hours of the show will be: **9:00 AM to 3:00PM**. Dealers with tables may begin set-up time after **7:30 AM**. Please do not leave before the end of the show.

The dealer fee is \$35.00 for one eight-foot table. One or two additional tables per dealer are also available at \$30.00 each. The fee includes a table and chairs. Each dealer will be responsible for supplying his own cases, covers, lights and electrical extension cords. Every effort will be made to accommodate individual table location requests on a first-come, first-served basis. Not that St. Matthew School does not permit the use of tape on tables, floors or walls.

The FIRESTONE COIN CLUB will hire show security. Admission to the show will be free to the public. The show will be broadly advertised in coin publication, local newspapers and flyers. There is ample free parking on the St. Matthew School grounds. Food and beverages will be available for purchase from a kitchen area adjacent to the show floor. A coin raffle drawing will be held at 3:00 PM.

Dealers shall acknowledge the FIRESTONE COIN CLUB will carry no insurance and none of its members or officers accept any responsibility for any items lost, stolen, or damaged; or any injury to any persons. Club reserves the right to cancel show for unforeseen or uncontrollable circumstances, including acts of God.
