The table fees are as follows: 8ft front wall table - \$375 each, 8ft table - \$325, 8ft x 8ft Front Corner \$600, 8ft x 8ft Back Corner \$525. The bourse area consists of a table, name sign, night cover, chairs, electrical outlet for lamp connections and 24/7 Police Security. Two badges will be provided for each 8 Foot table, and Four Badges provided for each corner table. Showcases and Lights are available on a reservation basis only. No free cases or lamps are furnished. Dealer will be charged \$20 for each lost key or failure to turn in rental showcase keys. <u>All dealers must be a current member of the TNA</u>, at least 21 years of age and have a valid Sales Tax number. Any balance is due by May 15, 2024. <u>Mail your \$25 TNA dues to Lawrence Herrera in advance of the show</u>. Application may be cancelled in writing and payment refunded prior to May 15, 2024. Cancellations made after May 15, 2024 will forfeit all money whether table is sold or not. Early Bird Badges are available for \$50. Table Deposit \$150.

Dealer Setup: Thursday, June 27th from Noon until 7PM.

Show Hours: Friday & Saturday, June 28th - June 29th: 9AM – 6PM / Sunday, June 30th: 9AM - 3PM Dealers and Early Birds may enter beginning at 8AM on Fri/Sat/Sun.

More than 50% of the material on display on an applicant's table must consist of numismatic material. Replicas, copies, or restrikes must be plainly marked and advertised to the prospective buyer. No altered or counterfeit numismatic material may be sold. The TNA reserves the right to restrict the sale of material which it deems contrary to the benefit of the "2024 Texas State TNA Coin & Currency Show" or its attendees and shall remove such items without recourse. A willful violation may result in individuals being barred from future TNA shows.

Bourse space shall not be resold, rented, or loaned to another dealer with the consent of the Show Producer. Dealers will be allowed one additional sign per table to place on their table. Such sign CANNOT EXCEED 2'x 3' and CANNOT BE SUSPENDED ON POLES OR ON WALLS. No balloons or blinking lights are allowed. **WHEN IN DOUBT ASK THE SHOW PRODUCER**.
