### To Reserve Your Table at Collectorama Lakeland Please Read & Fill Out The Contract Below

1. Full payment is required with contract, and is fully refundable if table is cancelled in writing within 30 days prior to the show start date.
2. Professional armed security begins at 3:00 PM Wednesday and continues to 4 PM on Saturday. Room must be cleared by 4 PM Saturday.
3. Security insists that ONLY those people wearing dealer badges are permitted behind tables during show hours for safety and security reasons.
4. Exhibit space is available to licensed dealers only, for displaying, buying and selling. This is an invitational show, with space sold on a first come, first served, basis. All applications are subject to approval and acceptance by Collectorama Inc. (CI). (CI) Show management must approve names of all sharing companies/dealers.
5. Security arrangements have been made and no express or implied warranty as to the effectiveness of such security is made by (CI). No negligence on the part of security, or (CI), shall subject (CI), its employees, or agents to any claim whatsoever. Each applicant is responsible to insure themselves against any loss which may be sustained, if he or she desires such protection. (CI), its employees, or agents are not liable for any losses during the show, or traveling to and from the show.
6. Non-tabled dealers may gain entry from 4-8 PM on Wednesday for a \$25.00 donation to Florida Youth Villa. A valid Sales Tax number and business card are required.
7. The sale of altered or counterfeit merchandise is strictly forbidden by Federal Law and (CI). (CI) reserves the right to prohibit the display or sale of any item not confirming to acceptable standards in (CI) sole and absolute discretion. Items of questionable authenticity shall be immediately removed if requested by (CI) staff.
8. The undersigned, both for the undersigned, and his agents, employees, and customers, releases and forever discharges (CI) harmless of all, and from all, manner of actions, suits, proceedings, debts due contracts, judgments, damages, claims or demands whatsoever in law or equity which may arise from any loss whatsoever including loss, damage and physical injury, however sustained, directly or indirectly, in conjunction with the show whether same results from a claim by the undersigned, its agents, employees, or customers. (CI) may plead this release as a defense and absolutely bar any claim, demand, or course of action instituted.
9. The undersigned shall keep his space in good condition and assume the full responsibility for any and all damages caused to said premises of the show facility.
10. The (CI) Bourse Chairman may, in the exercise of his sole discretion, expel any dealer from the show for any conduct deemed by the said Chairman to be detrimental to the show, or for failure to comply with any provisions of this agreement, in which case the dealer shall forfeit their table space and all fees.
