Additional badges will be available at \$15 per badge. Dealers will be expected to provide their own lights, extension cords, and display cases.

**24 Hour Security**: There will be an armed police officer on site for the duration of the show. The West Georgia Coin Show staff, officers, and committee are not responsible or liable for any loss of

property including but not limited to numismatic material, stock in trade, cash, or any other material. The bourse floor will be locked and access will be denied to all persons except the security guard, bourse chairman, and general manager. Any dealers needing emergency access to the floor after hours should contact the bourse chairman or general manager, who will then escort one dealer representative at a time to/from their booth. The security guards will not allow access to anyone not escorted by the bourse chairman or general manager.

**Booth Setup**: Hanging banners, shelving, foldout advertising, etc. may be used at your table as long as the line of sight and security are not interrupted. Security, the bourse chairman, and general manager have the authority to remove anything that creates a security issue or interrupts the line of sight.

**Prohibited Items**: The WGCS reserves the right to prohibit any items deemed inappropriate. This includes counterfeit coins that are not labeled as such, illegal contraband, etc. Smoking is not permitted inside the facility.

**Cancellation**: Cancellations may be in writing, or by email and receive a full refund prior to 30 days before show. Cancellations made after this will not be refunded. No refunds will be given if show opens up and operates as scheduled. Cancellations may result in table reassignment. Non-Numismatic or Bullion Items: Non-numismatic or bullion items are allowed on the following basis. Only one showcase may contain these items, unless arrangements have been made with the bourse chairman or general manager ahead of the show.

**Late Arrivals**: Dealers expecting to arrive late should inform the WGCS officers, bourse chairman, or general manager. Dealers who have not contacted any WGCS officers to notify late arrival by 12PM of Friday, May 31, will lose their table reservation for the rest of the show. Refunds will not be issued.

Applicants assume all responsibility, financial or otherwise, for all transactions conducted by such independent dealers and any other person behind their table. By signing this application the dealer is recognizing that others will have the right to rely on this representation.
