

NORTH CENTRAL ARKANSAS COIN CLUB 2025 BOURSE DEALER AGREEMENT

The 2025 Mountain Home Coin and Stamp Show sponsored by the North Central Arkansas Coin Club will take place on Friday August 29th from 9:00 AM to 5:00 PM and Saturday August 30th from 9:00 AM to 4:00 PM at the Ramada Inn 1127 Highway 62 East in Mountain Home, Arkansas. There will be armed security from 7-10 AM Friday during set up and from 3-6 PM on Saturday during takedown. The Club will provide overnight security from 5:00 PM Friday to 9:00 AM on Saturday. The hotel will offer room discounts if you mention the coin show. 12 foot tables are \$100.00 payable in advance and \$25.00 for an addition 6 foot table.

This agreement is entered into this _____ Day of _____, 2025 between the North Central Arkansas Coin Club (NCACC) and _____ hereinafter called the Dealer.

1. Each dealer is directly responsible to the taxing authorities for the collection and payment of any sales taxes. Arkansas has recently passed legislation exempting most coins from sales taxes.
2. Table fees apply to one-dealer occupancies of booths. Multi-dealer occupancies of booths are permitted AFTER the bourse is fully subscribed, in which case the Bourse Chairman may authorize two dealers sharing a booth. In such case a \$50.00 fee shall be paid immediately by the original contracting dealer.
3. Payment in full must accompany bourse applications. Checks (no credit card or debit card accepted) should be made out to the North Central Arkansas Coin Club. Return both copies of this contract to the North Central Arkansas Coin Club with your payment and one copy will be returned to you confirming your table(s). All dealers who signed up for tables for the 2024 will be guaranteed tables for 2025 and as close to the same spot on the Bourse floor that they had previously, if the application is returned by May 20, 2024.
4. In the event of cancellation of table space by the dealer a refund of all monies paid will be refunded providing the cancellation is received by August 1, 2024 at 8:00 PM. No refunds will be issued after that date.
5. Only family members/store employees whose names appear on the contract will be allowed in the Bourse area during set-up or overnight. To make this easier for security name badges will be provided and dealers are asked to wear them when on the floor.
6. Dealer agrees that the space provided will be **used exclusively by said dealer for the purchase, sale or trade of numismatic and philatelic (including postcards) items only.** No beanie babies, sports cars,

watches or other collectibles. Space limits us to generally 16 table set ups and we are advertising the event as a coin and stamp show.

7. Animals and pets are not allowed in the show area. Dealers are to furnish their own table coverings, lights, extension cords and show cases. Dealers are responsible for their own insurance and agree that the NCACC, the Ramada Inn and their employees, agents and associated persons shall not be held liable for any loss of any kind.
8. After much discussion the North Central Arkansas Coin Club has decided to charge a \$1 admission fee for all persons 18 and older. However, to attract more young people to the collecting world this fee will be waived if an adult brings a child between 6 and 15 to the show. The Club will sponsor giveaways for both adults and children and have a coffee booth set up for dealers.

Dealer booths consist of 12' front and 6' back tables. Booth cost is \$100.00. One additional 6' front table can be reserved at \$25 each. Dealers are responsible for table coverings, table lights and electrical extension cords.
