Any such infraction of this rule shall be construed as being against the best interests of numismatics and the Coin and Collectibles Fair. The penalty for such action shall be immediate ejection of the dealer from the bourse and the possible suspension and/or subsequent expulsion from future Coin and Collectibles Fair conventions. Booth will only be in the name, and only occupied by, the company (dealer) that is the registered exhibitor. The company (dealer) that is registered as the exhibitor may not sublet the booth to another entity without prior written permission of EV Scarsdale Corporation.
