Applicant agrees to assume all risk of loss, damage or injury, by fire, theft or otherwise to person or persons or property by reason of the condition of the bourse area, or by reason of the management, control or operation thereof, and releases IN Coin Shows LLC, their successors and assigns, from all claims for such loss, damage or injury sustained by the dealer, or by any employees of the dealer or by any persons whomsoever, whether caused by the negligence of IN Coin Shows LLC, its agents or assigns, or otherwise and the dealer agrees to indemnify IN Coin Shows LLC, their successors and assigns against all claims for such loss, damage, or injury, sustained by the dealer or by any agent or employees of the dealer, or by any person whomsoever. Applicant agrees to provide all licenses and permits and to obey all applicable statutes and ordinances.

CONDITIONS

1. Only individuals listed on the bourse application or otherwise officially accredited to booth holder ID Badges shall be permitted behind bourse tables booth. Participating dealers must belong to at least one of the following: American Numismatic Association (ANA), Central States Numismatic Society (CSNS), Professional Numismatist Guild (PNG) or Canada Numismatic Association (CNA).
2. Booth holder badges are not transferable and shall not be loaned or given to others. Violators of this provision may result in suspension of bourse privileges.
3. At least 75 percent of material on display must be numismatic in nature unless a written waiver is granted by the Show Director. Examples include: US, Confederate, Ancients, Foreign, Coins & Currency, Stamps, Tokens, Medals, Bonds, Coin related jewelry only and exonomia related material. No modern goods or collectibles are allowed (e.g.: porcelain, china, rocks, arrowheads, Mardi gras items, Indy 500 items, modern jewelry, dolls, beanie babies, NASCAR items, basketball cards, football cards, baseball cards or any other collectible items not related to numismatics,) and may be removed by the Show Director.
4. It is understood and agreed that no refunds of bourse fees will be made after September 1, 2025. Any request for refund must be presented in writing to the Show Director prior to September 1, 2025. You may also apply your bourse fee to the 2026 Indianapolis show in the event of a cancellation prior to September 1, 2025.
5. NO COINS DISPLAYS, BOOKS OR SIGNS OF ANY NATURE CAN BE PLACED ANY HIGHER THAN FOUR (4) FEET FROM THE FLOOR. SECURITY MUST HAVE A CLEAR VIEW ACROSS THE ENTIRE BOURSE AREA TO ENSURE SECURITY FOR THE ENTIRE AREA. SIGNS OR BANNERS NOT PROVIDED BY INDIANA COIN SHOW ARE PROHIBITED. NO SIGNS OR ADVERTISING MATERIAL OF ANY KIND MAY BE AFFIXED TO ANY WALL. A CONVENTION CENTER REQUIREMENT!
6. Booth holder agrees to maintain the booth in the arranged configuration as supplied by IN Coin Shows. Booth holder agrees not to use supplementary tables not supplied by IN Coin Shows as part of the standard booth configuration.
7. Show Director may reassign tables not claimed by the deadline date of the bourse fees of September 1, 2025. Contracts state all bourse fees and balances must be paid by September 1, 2025, and any booths not claimed by 10 AM on Friday September 1, 2025, may be reassigned with no refund to the booth holder.
8. No alcoholic beverages of any kind are allowed on the bourse floor at any time.
9. No subletting of bourse tables!
10. All dealers are required to have on hand their state registered retail merchants' certificate or a copy of the same.
11. Dealers offering the sale of altered, counterfeit, or spurious material **MUST** have it clearly marked as such. Dealers engaging in or conducting business in an **UNETHICAL** manner will be subject to expulsion from the show without recourse.
12. Dealers who don't return the table identifiers will be charged a flat \$5 fee for replacement.

important information stated below!

If a dealer wishes to retain his/her current table location for the Indiana State Coin Show, a bourse application and deposit of \$250 (or more) or the full table fee must be submitted by September 1, 2025. All dealers and additional personnel are required to have an ID badge provided by the show on dealer setup day. If a badge is misplaced or lost, there is a \$15 replacement charge.

All dealers that have paid for a bourse table at any Indiana State Coin Show must fill out and sign the bourse contract for that show. Full payment of all bourse fees is due on or before September 1, 2025. No refunds will be made after September 1, 2025. Any dealer that has not reserved a table by November 1st may not be listed in the program.

If you wish to cancel your table please send your request in writing to the Show Director, Matt Dinger, prior to September 1, 2025 at ISNA, ATTN: Matt Dinger 4983 N Franklin Rd Indianapolis, IN 46226. All dealers, their belongings and personnel must be out of the hall before 7 PM on Saturday November 22, 2025 or be subject to a \$1,000 penalty.
