We will be using **8-foot** tables priced at **\$110** for each regular sales table. An 8-foot backup table will be provided for each regular sales table purchased. There will be several **8-foot** sales tables positioned to prevent the public from approaching the backup tables or walking behind Dealers (End Caps / Blocking Tables). Due to space limitations there will be no backup table for the End Cap / Blocking Tables. Accordingly, these tables are priced at **\$75** each.

Not all Dealers will be assigned an End Cap / Blocking Table and no Dealer will have more than one End Cap / Blocking Table. Since it is impossible to know which Dealers will receive an End Cap / Blocking Table until nearer to the day of the show, the policy for this event is that participating Dealers are to submit **\$110** per table reserved, and if you are assigned an End Cap / Blocking Table among your sales tables you will receive a **\$35** rebate for the End Cap / Blocking Table at the show.

Tables may not be transferred, sold or shared without the consent of the Show Coordinator. Back-up table(s) may not be used for selling displays without an additional charge. **No refund for the cancellation of table(s) within thirty (30) days of show date.** The Show Coordinator must be notified if a dealer is not expected to show up for the show.
