Dealers are to check-in at registration no later than 10:00 am Sat. **Dealers must occupy their booths until the close of the event.** Requests for late check-in or early departure will be honored at the discretion of Coin and Collectibles Fair management. In the event that a dealer has not checked in by 10:00 am, their booth(s) may be reassigned or resold at the sole discretion of the Coin and Collectibles Fair management with no recourse to the original dealer.

No dealer may knowingly exhibit or offer for sale any illegal coins, counterfeits, forgeries, unmarked copies, or other spurious merchandise. Any such infraction of this rule shall be construed as being against the best interests of numismatics and the Coin and Collectibles Fair. The penalty for such action shall be immediate ejection of the dealer from the bourse and the possible suspension and/or subsequent expulsion from future Coin and Collectibles Fair conventions. Booth will only be in the name, and only occupied by, the company (dealer) that is the registered exhibitor. The company (dealer) that is registered as the exhibitor may not sublet the booth to another entity without prior written permission of EV Scarsdale Corporation.
