4. THE CHARACTER OF THE EXHIBITS SHALL BE LIMITED TO STAMPS, COINS, METAL BULLION, PAPER CURRENCY OR COIN/STAMP COLLECTING SUPPLIES AND MUST BE SUITABLE TO THE CHARACTER OF THE SHOW.
