Doors open on July 17th at 4pm and July 18th at 7am for dealer set-up. A reception table will be located just outside the show room with Dealer badges and table space assignments. An Operations table will be located in the show room during show hours. No obstructions are allowed around tables. Counterfeit Merchandise may not be offered for sale unless **CLEARLY** marked as such. Applicants will be required to conduct themselves in accordance with Federal, State, and Municipal laws. 24 Hour Security will be provided during the length of the show. Ft. Smith Police to conduct robust patrols during the show at the venue and the parking lot. Upon completion of the Dealer Contract you agree to hold harmless the Albert Pike Numismatic Coin Club (APNCC), the Wyndham Hotel Fort Smith City Center or its owners for any losses occurring during or after show hours. You agree to furnish your own insurance to cover the loss, damage, or theft of merchandise as it will not be provided by the show, the organizers, or the venue.
